Punjab CH Charanjit Channi and others meet Harish Rawat in Dehradun

New Delhi, (Hindustan Samachar) : Top leaders of Punjab Congress including Chief Minister and State Party President suddenly reached Dehradun to meet former Chief Minister of Uttarakhand Harish Rawat. Harish Rawat had resigned from the post of in-charge of Punjab last month keeping in mind the assembly elections in Uttarakhand. Punjab Congress President Navjot Singh Sidhu, Chief Minister Charanjit Singh Channi, State in-charge Harish Chaudhary and Assembly Speaker KP Rana reached Uttarakhand today. After the meeting, all the leaders of Punjab Congress left for Kedarnath Dham. After worshipping in Kedarnath Dham, all the leaders will return to Dehradun in the afternoon.

Low vaccination coverage in rural areas still baffles health officials

PRAYAGRAJ, (Hindustan Samachar) : Officials from the health department are investigating the causes for the district's low immunisation coverage in rural areas. Senior district health officials are visiting community and primary health care centres and talking with front-line health workers such as ASHA and ANMs to learn more about the reasons for low vaccine coverage in rural regions. Officials are also questioning ground health workers about the challenges they face, particularly in villages and blocks where immunisation rates are low.

Officials, on the other hand, recognised that ground health workers are overburdened by the various health initiatives and plans, but that they are fulfilling their jobs in assigned areas with great dedication. "Other program, such as routine immunisation, are once again on schedule," ASHAs told senior health officials, citing a drop in Covid-19 cases. Furthermore, because a number of health programmes and awareness campaigns are in the works, ground health workers are under a lot of pressure.

"We did continuous surveys during the pandemic, administered medicines, and are currently actively engaging in the Covid immunisation programmes," senior health workers said. They are concerned CHCs and PHCs have put additional pressure on ground health workers to expand vaccination in remote areas," she noted. Surprisingly, despite contacts with ASHAs and ANMs and favourable comments, residents in villages and blocks have not been showing up at vaccination centres. Meanwhile, health officials claimed that while immunisation rates have clearly grown in rural regions, some rural pockets have seen inadequate vaccine coverage.

However, in order to enhance vaccination rates in rural regions, the district administration have enlisted the help of gram pradhans, primary school teachers, and aganwadi workers. Furthermore, ground-level health workers have accused staff of other departments, such as gram panchayat, Rajiv Sevaks, kotedars, and staff of health centres, provide the necessary support to ramp up vaccination in rural regions.

Mankotia seeks separate constituency for Panchari-Landar-Bhamag

UDHAMPUR, (Hindustan Samachar) : Reiterating the demand of separate Assembly Constituency for Panchari-Landar-Bhamag area during his one-day tour at Galiote, Landar, Katti, Lattiyar, Kulliyar, Panchari and Meer Panchayats, former MLA Balwanti Singh Mankotia addressed protests at the Panchayat level. While addressing the gatherings, he said that this area can't develop until it becomes a separate Assembly constituency. "This farflung hilly area falls under three Assembly constituencies such as Reasi, Chenani and Udhampur and development here is not possible till a separate Assembly constituency is created for this area," he explained and stressed that the time has come to fight unitedly for separate Assembly.

Mankotia appealed to the members of the De-limitation Commission and to visit the entire area and take opinion of the people and then decide. He said that if

Gurez area of Kashmir can be a Legislative Assembly constituency with 14 thousand voters only, then why this hilly area whose voter strength is more than 40 thousand cannot be given a separate Legislative Assembly status? Mankotia also drew attention towards slow pace of road work from Kaintghal to Galiyot and appealed the administration to take cognizance of the same.

He also demanded that pending MGNREGA liability of the labourers for the years 2016-17-18 should be cleared as early as possible. He also highlighted the difficulties being faced by people in getting benefit of Pradhan Mantri Awas Yojana and crop loss due to heavy rains and hail storms in this area last week. On this occasion, J. Leader Surjit Singh Sarpanch, Sh. Leader Singh, former Sarpanch Rajender Singh, former Sarpanch Rajender Sharma, Harjeet Singh Kulchatter Singh, Harjeet Singh besides many Panchs Sarpanchs and locals were present in large number.
